
### **Remaining Estate Assets**

Red Lake County Social Services is committed to being good stewards of our state's resources. Therefore, Red Lake County Social Services approved the guidelines as set forth in this brochure outlining the family's usage of the decedent's remaining assets.

After funeral expenses have been paid, all remaining assets are subject to a Medical Assistance claim on behalf of the State of Minnesota and Red Lake County. Thus, any personal expenses including, but not limited to, clean up expenses for home or apartment must be approved by Red Lake County Social Services prior to the cost being incurred.

Collection worker to discuss approved costs for services prior to expending funds from the Decedent's estate.

...would like to extend our sincere sympathy to your family at this difficult time. If your loved one had been on medical assistance after the age of 55 and/or had been in a long-term care facility, or had received General Assistance (GAMC), or Alternative Care at any age, there are certain guidelines that Red Lake County Social Services has put in place regarding final funeral expenses.

# REASONABLE FUNERAL EXPENSES

Reasonable Funeral expenses are expenses directly related to the funeral goods/services and burial site goods/services made to finalize the remains according to government laws and the religious beliefs or wishes of the individual.

# REASONABLE FUNERAL EXPENSES TO BE PAID FROM DECEDENT'S ESTATE

Certificate of Death (up to 5)

Basic Funeral Home Services (cremation, embalming, least expensive urn, or casket)

Vault (Urn or Casket)

Ground Transportation of the body

Cemetery Plot

Cemetery Burial opening/closing (Casket & Vault or Urn & Vault)

Grave Marker with Engraving (Lowest cost stone, flat marker, plus placement or add Date and/or Name to existing marker)

One Memorial Service (public visitation service, funeral service, or grave site service)

One Basic Newspaper Obituary

One Clergy/Officiant

One Musician

#### PREPAID BURIAL TRUSTS

If a decedent has a prepaid burial trust, the funds must "be distributed for the payment of the atneed funeral goods, funeral services, burial site goods or burial site services selected with any excess funds distributed to the beneficiary's estate". See Minn. Stat. section 149A.97, subdivision 3a, clauses (9) and (10). If the funeral costs exceed the dollar amount of the prepaid burial trust or insurance funds, reasonable increases for inflation will be allowed.

Police Escort
